April 2017

Stuart Bingham is charged as follows, that he:

1. Between 1st October 2009 and 30th April 2010 placed bet(s) in respect of the result, score, progress, conduct or any other aspect of the Tour and/or any Tournament or Match in which the he was participating using his betting account with the user name 'Ballrun147' in breach of Rule 3.1.1.1 of the WPBSA Members Rules then in force.

And/or

2. Between 1st July 2012 and 30th November 2013 placed bet(s) in relation to the result, score, progress, conduct or any other aspect of the Tour and/or any Tournament or Match in events sanctioned by the WPBSA, WSL, WBL, WLBS or WDBS using his betting account with the user name 'Ballrun' in breach of Rule 2.1.1.1 of the WPBSA Members Rules then in force.

And/or

3. Between 1st September 2002 and 25th August 2009:
 - a. placed bet(s) in respect of the result, score or any other aspect of any snooker or billiards match in which he is playing using the betting account in the name of

Gary Purkiss with Stan James in breach of Rule 2.7 of the WPBSA Members Rules then in force, and/or

- b. caused bet(s) to be placed in respect of the result, score or any other aspect of any snooker or billiards match in which he was playing using the betting account in the name of Gary Purkiss with Stan James in breach of Rule 2.7 of the WPBSA Members Rules then in force.

And/or

4. Between 25th August 2009 and 1st January 2012:

- a. Placed bet(s) in respect of in relation to the result, score, progress, conduct or any other aspect of the Tour and/or any Tournament or Match in which he was participating using the betting account in the name of Gary Purkiss with Stan James in breach of Rule 3.1.1.1 of the WPBSA Members Rules then in force.
- b. Solicited, induced, enticed, instructed, persuaded, encouraged, facilitated, authorised or permitted Gary Purkiss to enter into Bet(s) for his direct or indirect benefit in relation to the result, score, progress, conduct or any other aspect of the Tour and/or any Tournament or Match in which he was participating in breach of Rule 3.1.1.2 of the WPBSA Members Rules then in force.

And/or

5. Between 1st January 2012 and 11th January 2017:

- a. Placed bet(s) in respect of in relation to the result, score, progress, conduct or any other aspect of the Tour and/or any Tournament or Match in which he was participating in breach of Rule 2.1.1.1 of the WPBSA Members Rules then in force by
 - i. Using the betting account of Gary Purkiss with Stan James, and/or
 - ii. Using the betting account of Gary Purkiss with the user name 'BigPurk', and/or
 - iii. Using the betting account of Curtis Braithwaite with Coral.
- b. Solicited, induced, enticed, instructed, persuaded, encouraged, facilitated, authorised or permitted:
 - i. Gary Purkiss to enter into bet(s) for his direct or indirect benefit in relation to the result, score, progress, conduct or any other aspect of the Tour and/or any Tournament or Match in which he was participating in

breach in breach of Rule 2.1.1.2 of the WPBSA Members Rules then in force, and/or

- ii. Curtis Braithwaite to enter into bet(s) for his direct or indirect benefit in relation to the result, score, progress, conduct or any other aspect of the Tour and/or any Tournament or Match in which he was participating in breach in breach of Rule 2.1.1.2 of the WPBSA Members Rules then in force.

6. Between 1st December 2014 and 8th November 2016:

- a. Placed bet(s) in respect of in relation to the result, score, progress, conduct or any other aspect of the Tour and/or any Tournament or Match in which he was participating in breach of Rule 2.1.1.1 of the WPBSA Members Rules then in force by
 - i. Using the betting account(s) of Phillip Alden, and/or
 - ii. Placing bet(s) with Phillip Alden.

And/or

- b. Solicited, induced, enticed, instructed, persuaded, encouraged, facilitated, authorised or permitted Phillip Alden to enter into bet(s) for his direct or indirect benefit in relation to the result, score, progress, conduct or any other aspect of the Tour and/or any Tournament or Match in which he was participating in breach in breach of Rule 2.1.1.2 of the WPBSA Members Rules then in force.
